1. Application
2. Corporate or Business Check (*see below for amount*)
3. Buildings Department Certificate of Approval certifying to exact seating occupancy
4. Fire Dept. Approval certifying to exact seating occupancy
5. Articles of Incorporation
6. Corporation Bond of \$10,000 (not applicable for wrestling)
7. Guarantee Bond of \$20,000 (to be filed with the State Comptroller)
8. Floor Seating Plan (blue print) showing exact seating capacity
9. Certified Copy of Minutes
10. Lease of premises if applicable
11. Two (2) Sets of Fingerprints for all officers. All fingerprints must be on Commission provided cards. Each set of fingerprints must be accompanied by a money order in the amount of \$99 payable to the *Division of Criminal Justice*.
