REMOVAL FUND: APPROPRIATION AND ANTICIPATED PAYMENTS
IN FY 20-21

The following is a brief summary of collected fees and payments of funds granted from the Vandalism, Abandonment and Monument Repair or Removal Fund. The vast majority of monies are collected concurrent with the submission of annual reports, generally filed within the first three months of the calendar year.

2020 calendar year vandalism collections were \$430,504. Assessment collections were \$248,091. Fiscal year collections from April 1, 2020 are: Vandalism \$46,172. Assessment \$31,259.

The entire \$2,000,000 2019/20 appropriation was spent by March 31, 2020. \$776,397.36 is still unpaid from prior years applications and will be paid from the FY 2020/21 appropriation, leaving \$1,223,620.64 available for new applications, assuming a \$2,000,000 2020/21 appropriation
