**Introduction and Recommendation**

I received an application (Exhibit A) for the repair of 38 monuments that were vandalized in Vale Cemetery in the City of Schenectady. The application was submitted by Bernard McEvoy, M.D., Vice President of Vale Cemetery. Included with this application were two estimates: one from Melody Howarth (Exhibit B) for memorial repair totaling \$8,805; one from Bottone Memorials (Exhibit C) for memorial repair totaling \$10,730.

Also included was a legal notice (Exhibit D) that ran for three consecutive weeks in The Record.

I recommend approval of this application.

## **The Monuments**

I visited the cemetery and found that all 38 monuments under application were toppled. The cemetery has had no response to the legal advertisement which it placed. It should be noted that both of the estimates indicate repair of 38 monuments, however, the Schenectady Police report notes 30 monuments vandalized. I asked Dr. McEvoy about the discrepancy and he responded that the additional 8 monuments were discovered after the initial police report. This would not be unusual for Vale Cemetery has had a history of recurring vandalism.

## **Recommendation**

The cemetery is current with its payments to the vandalism fund, and with the filing of its annual reports. The previous grant for an approved vandalism application in 2018 was used appropriately. All documents appear to be in order, and this appears to be a legitimate claim for \$8,877.16. I recommend that this application be approved.


