Fees may be paid by check or money order (made payable to the Department of State) or by MasterCard or Visa, using the enclosed credit card authorization form. Do not send cash.
- ▶ Attach a resume which certifies the claimed expertise in the subject matter presented in the course.
- ▶ An approved sponsor which engages program instructors to present a course or part of a course determined as real estate appraisal related technical subject(s), must make application to the Department certifying the instructor's claimed expertise. Approval is granted to individuals based on their qualifications.
- ▶ **CHILD SUPPORT STATEMENT.** A signed Child Support Statement is mandatory in New York State (General Obligations Law) - regardless of whether or not you have children.
Any person who is four months or more in arrears in child support may be subject to having his or her business, professional and driver's licenses suspended. The intentional submission of a false written statement for the purpose of frustrating or defeating the lawful enforcement of support obligations is punishable pursuant to Section 175.35 of the Penal Law. It is a class E felony to offer a false instrument for filing with a state or local government with intent to defraud.
