To Whom It May Concern,

Please allow this memorandum to serve as a cover letter to Livingston County's 2019 Shared Services Panel submission, for implementation in 2020 and beyond. Our proposed plan with applicable savings, with project descriptions and plan elements are included below.

In the development of this plan, we held a series of three public meetings in total, with one on July 8, 2019 and two on December 18, 2019. Panel members and representatives from Towns and Villages were personally invited to such meetings.
