Practical Examination Scheduling

Practical examinations must be scheduled online. After your application is approved, an email will be sent to the email address provided on your application. The email will contain a link where you may schedule your exam.

A \$15 non-refundable fee is due at the time you schedule your examination. If you need to reschedule your examination, you must do so at least six days before your scheduled examination date. **Should you cancel your appointment, arrive late to your scheduled examination, or do not appear for a scheduled examination, you will forfeit the examination fee.**

Mandatory COVID-19 Precaution checklist for exam candidates

Do not appear for an exam if you meet any of the below:

- Have a temperature greater than or equal to 100.0 degrees Fahrenheit.
 - Have had known close contact with a person confirmed or suspected to have COVID-19 in the past 14 days.
 - Have traveled within a state with significant community spread of COVID-19 for longer than 24 hours within the past 14 days. For a list of states currently under New York's travel advisory requiring a 14-day quarantine upon return, please visit: <https://coronavirus.health.ny.gov/covid-19-travel-advisory>
 - Currently experiencing ANY of the following symptoms:
 - Cough (new or worsening);
 - Shortness of Breath (new or worsening);
 - Troubled Breathing (new or worsening);
 - Fever;
 - Chills;
 - Muscle Pain (new or worsening);
 - Headache (new or worsening);
 - Sore Throat (new or worsening); or
 - New Loss of Taste New Loss of Smell
 - Have tested positive for COVID-19 through a diagnostic test in the past 14 days.

- If you must reschedule your exam due to illness, email exams@dos.ny.gov to reschedule.
 - Mannequins have replaced live models for this exam. Do not bring a live model to an exam site. See the supply list for details regarding mannequin requirements.
 - Do not appear to the exam site unless your requested exam date is confirmed.
 - Wear a face covering or mask to your exam. Face coverings are mandatory at exam sites.
 - In addition to wearing a face covering or mask, you must wear eye goggles or a face shield while performing examination procedures.
 - Maintain 6 feet from others when possible at an exam site.
 - Be prepared to sanitize your hands before and after your exam. Hand sanitizer is provided by the exam site; you must bring your own hand sanitizer to use during the examination.
 - Bring a sanitized pen with you to your exam.

Note: If you have submitted the appropriate documentation to request special testing arrangements, a representative from the Division of Licensing Services will contact you with your exam schedule. Examinations which require special testing arrangements cannot be self-scheduled through the online system.

Admittance to the Practical

For admittance to this examination you **MUST** bring a form of government-issued signature identification which must be photo-bearing. Your identification **must be current** and from the following list:

- Driver's license
- State-issued Identification (ex. Non-driver ID)
- IDNYC Card (NYC Identification Card)
- Military ID
- United States Passport
- Employment Authorization Card (issued by U.S. Citizenship and Immigration Services)
- United States INS Issued ID
- Certificate of US Citizenship
- Foreign Passport
- Brazilian, Mexican, Honduran, and Ecuadorian Consular ID

Your ID must match the exact first and last name used to schedule the exam. If your last name is hyphenated, please be sure to include your full name. If your name does not match your ID exactly, we reserve the right to deny you access to the examination.

Preparing for Your Practical

You should arrive for your examination with appropriate attire for providing barbering services. You will be expected to follow the following guidelines:

- 1) A clean barber jacket must be worn.
- 2) A clean face covering (or mask) that completely covers the nose and mouth must be worn throughout the entire examination.
- 3) Face shield or safety goggles must be worn throughout the entire examination in addition to face covering.
- 4) Closed-toe and closed-heel shoes that cover top of foot (no canvas).
- 5) No gum chewing, cell phone use, or other technological devices are permitted.
- 6) Hands washed with soap and water prior to your arrival; you must use a hand sanitizer containing 60% or more alcohol throughout the exam.

Note: The use of disposable gloves is optional.

You must bring a mannequin with you to the examination that meets the requirements as specified on the supply list. Failure to do so will result in your disqualification. Your mannequin's hair may be of any texture but must be at least 2 inches long. Additionally, your mannequin should not have any facial hair. No live models will be allowed.

You must also bring your own examination supplies and implements as outlined on the supply list. Failure to provide any of the necessary supplies and implements may preclude you from being allowed to perform some of the examination procedures. **Note: Sharing of supplies between examinees will not be allowed.**

Practical Examination Procedures

The barber practical examination consists of a series of tasks that you must perform within an allotted time frame for each procedure. You will be required to demonstrate the following procedures within the specified time:

- **Professional Appearance, Preparation of Work Area & Client Preparation** (10 minutes)
- **Hair Cutting Techniques** (30 minutes)
- **Shaving – Facial Hair** (15 minutes)
- **Facial Massage** (10 minutes)
- **Clean Up of Work Area** (5 minutes)

Note: You will not be shampooing your client (mannequin).

Examination procedural information and tasks are available on our website at www.dos.ny.gov. You will not be allowed to use these documents during your examination. The barber practical will take approximately 1¼ hours to complete.

Safety and infection control procedures must be adhered to during the entire examination. Please familiarize yourself with additional safety and infection control practices that are now required at practical exams.

Examination Cancellations

Exams may be canceled due to weather conditions or other emergencies.

Examination Results

You will be notified by email once the examination results are available for viewing. You must login to your NYS License Center account to view your results under the examination section. Applicants who have passed the practical examination will be issued a New York State Barber License in the mail. If you fail the exam, you may login into your NYS License Center account and schedule another examination. Results will not be given at the examination or over the telephone. You may not appeal your examination results.

Examination results are reported as either passed or failed; you will not receive a numerical score. Passed examination results are only valid for a period of five years. Examination results will be available in your online account. Log into your online account at <https://my.ny.gov/>. If you fail the exam, you can schedule another examination by utilizing your online account.

Requesting an Analysis

If you fail your examination, you may request an analysis of your practical examination by emailing exams@dos.ny.gov. An analysis is a report or breakdown of your practical examination scores to assist you in identifying your strengths and weaknesses. You must request an analysis within 60 days of your examination date. We will not provide analyses to individuals who have achieved a passing mark on the practical examination.
